

## CONTRIBUTION AGREEMENT

### Section One

### Section Two

other proceedings which may arise as a result of the performance of services hereunder. This section does not require the Sponsor to be responsible for or defend against claims or damages arising solely from acts or omissions of the Waterloo Schools, its officers or employees.

This agreement is made pursuant to and shall be governed by the laws of the State of Iowa. This Agreement is binding upon the parties hereto, their successors and assigns. The instrument contains the entire agreement between the parties, and not statement, promises, or inducements made by either party or agent or either part that are not contained in this written contract shall be valid or binding. This contract may be enlarged, modified, or altered except in writing signed by the parties and endorsed hereon.
